## Project Description

According to the Bank's website, the proposed IFC investment supports the issuance of 3-year sustainability bonds ("SB") denominated in TZS and in USD in Tanzania by NMB Bank, with an own-account subscription of up to US\$30 million equivalent. IFC will act as co-anchor for NMB's TZS denominated SB and aims to mobilize third-party investors in the Bank's USD-denominated tranche.
