## Project Description

According to the IFC, the proposed investment is an unfunded risk participation facility (RPF) between IFC and Santander Bank Polska SA for renewable energy project finance loans of up to PLN 1,900 million (US\$ 470 million equivalent) in aggregate, originated by the Bank. The Project is expected to support Santander Bank Polska in increasing access to finance for long term local currency energy transition projects in Poland, including projects led by small and medium sized enterprises (SMEs).

The proposed facility will support development of renewable energy in Poland, primarily onshore wind, and solar sub-projects. The Project will not support activities on IFC Exclusion List, coal related sub-projects, hydro energy projects, offshore wind, and higher risk transactions.
