## Project Description

As stated by the IFC, the proposed investment consists of a senior A loan of up to US\$ 20 million to Socur S.A. ("Creditel") to finance the development of a green hydrogen (GH) plant in Uruguay. Creditel will own the project assets, which in turn will be operated by and leased to Kahirós, a special purpose vehicle. The A Loan will have 7-year tenor, which IFC will help structure as a green loan.

The Sub-project facilities will be constructed in Fray Bentos, the capital of the Rio Negro Department in southwestern Uruguay.

As stated by the IFC, Creditel is fully owned by Banco Santander S.A. (Spain). The Sub-project will be built and operated through Naspuy, S.A. (“Kahirós”), an SPV equally owned by Ventus Global S.A., Fraylog S.A., and Hyundai-Fidocar S.A..
