Project Description

According to the Bank's website, the proposed IFC investment is a subscription to a Sustainability-Linked Bond ("SLB") of up to EUR120 million (approximately US\$136 million) to be issued by Techtronic Industries Company Limited ("TTI"). Proceeds from the proposed SLB will be used to expand TTI's operations in Viet Nam, mainly for the construction of a second factory at Saigon High-Tech Park. The proposed SLB will help reduce the Company's greenhouse gas emissions and promote gender inclusion.

The Company's current management team owns approximately 2.82% in the Company through a share awards scheme. The Company's remaining approximately 75.18% shareholding are held by public shareholders.
