According to the Bank's website, IFC provided a financing package (the "Financing Package") to Hikma Finance USA LLC (the "Borrower"), a wholly owned subsidiary of Hikma. Proceeds of the IFC Loan (as defined below) and the Bond (as defined below) which, for the avoidance of doubt, is limited to IFC's subscription of US\$50 million in the Bond, will be used to support the Company's general corporate purposes including acquisitions, capital expenditure, working capital needs, and any investment in research and development in the Middle East region, as well as debt refinancing of the Group (the "Project").

This is a Category B project according to IFC's Environmental and Social Sustainability Policy. Based on IFC's review, the proposed project will have limited adverse E&S impacts that are few, site specific, largely reversible, and readily addressed through existing mitigation measures and good international industry practices (GIIP).
