*IMC S.A.*, together with its subsidiaries, operates as an integrated agricultural company in Ukraine and internationally. The company operates through two segments; Crop Farming, and Elevators and Warehouses. It cultivates corns, sunflowers, wheat, barley, pea, buckwheat, millet, soybean, and oilseeds. The company also engages in the agricultural and farming production; bakery production; and trading business, as well as operates grain elevator. In addition, it provides storage facilities. The company was formerly known as *Industrial Milk Company S.A.* and changed its name to IMC S.A. in May 2017. IMC S.A. was founded in 1998 and is based in Luxembourg, Luxembourg. IMC S.A. is a subsidiary of Agrovalley Limited.
