## Project Description

The Government of the Republic of Namibia (GRN) has identified the development of a large-scale green hydrogen industry in various regions in Namibia as a priority to support both economic growth in Namibia and assist the world in achieving its decarbonisation goals. Hyphen Hydrogen Energy (Pty) Limited (Hyphen) successfully bid on and has been awarded the rights to undertake a feasibility assessment for the development of Namibia's first fully vertically integrated GW scale green hydrogen project, and if feasible, implement the project on ~4,000km<sup>2</sup> of land within the Tsau //Khaeb National Park (TKNP). The project is the first step in the implementation of GRN's green hydrogen strategy. Hyphen plans to develop the project in phases.

Over a two-year period, the International Finance Corporation (IFC) will provide advisory services to Hyphen, focused on good international industry practices in biodiversity management. IFC's role will include reviewing and guiding the scope of Hyphen's biodiversity related assessments and advising on stakeholder engagement and consultation.
