## Project Description

The bank affirms that Santa Vitoria do Palmar wind power project (the “*Project*” or “*SVP*”) will add 207 MW of renewable energy to the Brazilian electricity system, thus directly supporting the Government of Brazil’s (“*GoB*”) priorities to ensure a stable long-term electricity supply and the diversification of its energy matrix with the expected addition of around 10 GW from renewable sources by 2018. The Project consists of the construction of 12 adjacent wind farms totaling 207 MW and its associated facilities in the state of Rio Grande do Sul, located in the South of Brazil.
