Project Description

The Puerto Bolívar transport project (the "Project") aims to finance the capital expenditure required for the first stage of an investment plan for the modernization, operation and maintenance activities of the Puerto Bolívar Port Terminal, located at the province of El Oro, Ecuador. This investment will expand the port's capacity to operate containers from 120,000 TEUs to up to 600,000 TEUs per year.

One of the focuses of the project seems to be Shrimp and Banana exports.

The Project is part of the privatization process of the existing Puerto Bolívar.
