#### **Project Description**

According to IIC website, the proposed financing consists of a credit line in favor of Agrícola Pampa Baja S.A.C for up to US\$25 million with a 10-year tenure, a 2-year grace period and a collateral package with a coverage ratio of 110% at liquidation value. The funds will be allocated to: (i) capital investments for the plantation of 600 additional hectares of avocado and the construction of industrial packing facilities (up to US\$9 million); (ii) permanent working capital (up to US\$8 million); and (iii) refinancing of short and medium-term debt (up to US\$8 million). The total cost of the project is US\$ 85 million. The structure provides sufficient flexibility to address common contingencies in projects of this nature, in addition to including for the first time at IDB Invest the "El Niño" clause that allows the client to reschedule one year's amortization in case of the manifestation of a climatic event that has adverse effects on the ability to repay.
