### Project Description

As stated by the NDB, the Program supported the financing of the Government of Brazil's expenditures incurred under Law 13.982/2020 that "establishes exceptional social protection measures to be adopted during the period of confrontation of the public health emergency of international importance resulting from the coronavirus (COVID-19)". The Program supported (i) the maintenance of minimum income levels for informal, self-employed and unemployed workers with the Basic Emergency Aid; and (ii) families under the cash transfer Bolsa Familia Program that are also eligible for the Basic Emergency Aid. The Program contributed to improving the living conditions of vulnerable people, in the face of the COVID-19 crisis, which is affected income and employment levels. The Program was specifically related to the Government of Brazil's response to the COVID-19 outbreak. The Program helped ensuring that strong fiscal support was in place to combat the outbreak and that priority public investment projects in 2020 were implemented, and to helping the economic recovery of the country. The Program supported the implementation of non-pharmaceutical interventions, such as social distancing while contributing to safeguard the living conditions of the most vulnerable population in Brazil during the COVID-19 crisis.

The Program was implemented by the Ministry of Citizenship of the Government of Brazil to support minimum income levels for the most vulnerable population, including informal, self-employed and unemployed workers, and poor families with a Basic Emergency Aid. The Ministry of Economy was the Borrower. The World Bank/IBRD, the Interamerican Development Bank, KfW, AFD and the Development Bank of Latin America also provided financial support to the Brazilian Government efforts to combat the COVID-19 pandemic.
