Project Description

As stated on the project disclosure page, the NDB will provide the loan to HUIFL, which will be used to finance environmental protection and energy efficiency sub-projects. HUIFL will use the loan proceeds to acquire and lease equipment to lessees for implementation of sub-projects related to wastewater treatment, solid waste treatment and waste metallurgical gas utilization for power generation. The eligible locations for Sub-Projects will exclude four tier I cities to support investments flow into less developed regions.
