### **Project Description**

According to the NDB, the objective of the Loan is to promote infrastructure investments in South Africa by providing financing to (i) water and sanitation and (ii) social infrastructure – healthcare sector. This is in line with the NDP 2030 which has outlined the need to (a) provide reliable and sustainable water supply to areas that have historically been underserviced or face irregular water access and thereby contributing to water security in South Africa; (b) support private sector investments in healthcare facilities thereby improving access to quality healthcare for the country's citizens and (c) support economic growth within the regions where the Project will be implemented.

### **Financial Intermediary**

Financial Intermediary: A commercial bank or financial institution that receives funds from a development bank. A financial intermediary then lends these funds to their clients (private actors) in the form of loans, bonds, guarantees and equity shares. Financial intermediaries include insurance, pension and equity funds. The direct financial relationship is between the development bank and the financial intermediary.

### **Private Actors Description**

As stated by the NDB, Industrial Development Corporation of South Africa Limited (IDC), as a state-owned national financial intermediary, plays a key role in mobilizing funding for infrastructure aligned with NDP goals to contribute to investments in the two sectors. This aligns with the priorities of the government of South Africa aimed at (i) improving water security, better water and sanitation services, and driving economic growth through water-intensive industries, and (ii) access to quality healthcare for all citizens.
