Project Description

As stated by the NDB, the Project aims to contribute towards achieving enhanced mobility and improving the overall quality of life in Maceió. By facilitating a safe, reliable, and affordable mass-transit transport system for the local population, it will expand access to workplaces, education, and essential services for public transport users throughout the city. Additionally, the project aims to prioritize the use of public transportation and discourage the use of individual transportation, fostering a more sustainable and efficient urban mobility system.

The Project comprises the following key components:

- Component I – Development of a BRT System: implementation of bus lanes and associated infrastructure, including a dedicated BRT corridor along Avenida Fernandes Lima, pavement rehabilitation of BRT feeder lanes, construction or upgrading of BRT terminals and bus shelters, and fleet acquisition.
- Component II – Intelligent Transportation System (ITS): development of an advanced ITS which will primarily enable centralized management of the BRT system, while certain smart systems will have a broader application across the city's public transport network.
- Component III – Capacity Building, Institutional Strengthening and Project Management: this component focuses on strengthening the capacity of key project stakeholders to ensure smooth project implementation.
