Project Description

As stated on the World Bank's website, the development objective of the Energy Sector Support Project for Malawi is to increase the reliability and quality of electricity supply in the major load centers. There are four components to the project. The first component of the project is electricity network strengthening and expansion. Rehabilitation, upgrade and expansion of priority parts of the existing distribution and transmission system, including extension of the network in selected peri-urban areas.

The second component of the project is generation and transmission feasibility studies. Financing for feasibility studies (and associated environmental & social assessments) for development of new hydropower generation and transmission capacity required to meet Malawi's growing energy demand.

The third component of the project is demand side management and energy efficiency measures. Financing for demand-side management and energy efficiency activities in urban areas to help address Malawi's power capacity deficit.

The fourth component of the project is capacity building and technical assistance. Financing for institutional strengthening and technical assistance to both the Ministry of Natural Resources, Energy, and Environment and ESCOM (Electricity Supply Corporation of Malawi) to support their efforts to further develop Malawi's energy sector.
