## Project Description

The original project objective, which remains unchanged, are to assist the Government to: (i) restore the most essential functions of the health delivery system; and (ii) strengthen both public and private health sector capacities, so as to improve the efficiency and responsiveness of the health sector to the needs of the population. The project has two components: (a) restoring essential health services through (i) restoring health service delivery in four priority districts (Bombali, Koinadugu, Kono and Moyamba), and (ii) supporting three priority technical programs to improve their performance and control

infectious diseases of high public importance in Sierra Leone (malaria, tuberculosis (TB), and (b) strengthening public and private sector capacity through (i) fostering decentralization and improving the performance of District Health Management Teams; (ii) strengthening the key MoHS support programs in the area of human resources development, planning, financial management, monitoring and statistics, procurement and donor/NGO coordination; and (iii) promoting development of the private sector and participation of civil society in the health sector.
