According to the bank, the objective of the project is to help Nicaragua become ready for future REDD+ implementation by preparing those key elements, systems, and/or policies needed, generally referred to as the REDD+ Readiness Package, in a socially and environmentally sound manner.

REDD+ is an incentive developed under the United Nations Framework Convention on Climate Change (UNFCCC) to financially "reward" developing countries for their greenhouse gas emission reduction results from Deforestation and forest degradation, conservation of forest carbon stocks, sustainable management of forest and increase of forest carbon stocks.
