#### **Project Description**

This project finances three components aimed at the health sector: i) improving the quality and integration of health service delivery through support for the development of an information sharing system that links health care institutions, development of performance scorecards for primary care and hospitals, and strengthening of the mechanisms for quality monitoring and quality assurance; ii) modernizing the hospital sector through strengthening management and accounting systems for hospitals and providing technical support for policy reforms to strengthen hospital accountability and autonomy; and iii) strengthening the strategic purchasing and governance of the health system.
