Project Description

The Renovation of General Education Project for Vietnam aims to raise student learning outcomes by:

- (i) Revise and implement a competency-based approach curriculum
- (ii) Create and disseminate new textbooks together with the revised curriculum to improve the instruction's effectiveness.

According to the project's abstract, there are 4 components to the project's implementation:

"The first component will support the development and implementation of a revised curriculum for all school subjects from grades 1-12.

The second component is the development and dissemination of aligned textbooks. This component will support the development a set of textbooks aligned with the new curriculum and the provision of aligned textbooks to schools with high numbers of economically-disadvantaged students. This component includes two sub-components: development of textbooks aligned with the new curriculum; and provision of textbooks to disadvantaged schools.

The third component is the learning assessment and analysis for continuous improvement of curriculum and policy. This component includes three sub-components: establishment of the National Centre for Sustainable Development of General Education Quality (NCSERGEQ) and the National Center for Foreign Language Testing (NCFLT); research and capacity-building on curriculum development and assessment; and expansion of the national large-scale assessment system.

Finally, the fourth component is the project management. This component combines project management with monitoring and evaluations (M&E)".
