The development objective of the Support to Agro-Industrial Competitiveness Project for Mali is to increase the processing of agricultural products for targeted value chains in the selected geographic area. The Project wiill support the Government of Mali agropoles strategy through the following four components. 1) expand mango processing and investment opportunities will aim at increasing mango production, processing and export, through the following two sub components: (a) promote mango processing and exports; and (b) strengthen institutional capacities at API-Mali; 2) improve access to mango production areas will finance two types of infrastructure that are physical inputs to the mango value chain: (a) the rehabilitation of 300 km of rural roads and (b) the construction and modernization of seven post-harvest facilities including collection and conditioning centers.
