### Project Description

This project targets the nutrition status of children under five through two main components:

- (i) Improving Food and Nutrition Security through the diversification of agricultural production and utilization of nutritious natural ingredients readily available in the target villages; and
- (ii) Strengthening community-based nutrition care and practice by providing group and peer counseling, supporting a mother-to-mother network, and promoting antenatal care conducted in the community health center.

The Project Development Objective is to improve the nutrition status of children of age less than five in the target villages through improving the child feeding practices, maternal and child care, and to diversify sources of nutrition of pregnant women, infants and young children.
