## Project Description

The development objective of the Reproductive Health Project for Burkina Faso is to improve the utilization and quality of reproductive health services in the Recipient's territory, with a particular focus on selected regions of the Recipient. The additional financing (AF) will continue to support the provision of a package of health services through results-based financing (RBF) and the reinforcement of reproductive health services. In addition, the AF will: (a) support the implementation of a number of recommendations from the mid-term review (MTR) that was concluded in July 2015; (b) help finance the costs associated with the expansion of ongoing piloted strategies such as community-based targeting (CBT) of the poor and community-based health insurance (CBHI); (c) introduce interventions that will address the needs of population groups vulnerable to human immunodeficiency virus (HIV) and acquired immunodeficiency syndrome (AIDS); and (d) provide more time for the completion of the ongoing RBF impact evaluation. The AF will also fill the expected financing gap in resources needed to complete the RBF pilot and impact evaluation (IE) in 2017, in particular the added cost of the new interventions that aim to increase access of the poor to health services through RBF subsidies and incentives.
