## Project Description

According to website of the World Bank, the development objective of the 'Punjab Cities Program' will provide capacity building and institutional support to 16 urban local governments in Punjab province to strengthen urban management and service delivery. The total scope and operations of the program fall under two windows, which include:

**Window-1 Performance Based Grants:** The program funds will be used by participating secondary cities for

a) financing eligible infrastructure investments and b) Financing city systems for investment planning, budget allocation, procurement, expenditure management, environmental and social management, and systems and procedures for Operation and Management (O&M) of infrastructure and services.

**Window-2 Institutional Strengthening:** It will support provincial government agencies to develop and implement systems for human resource management, grant management, reporting and audit as well as MC performance assessment.
