Project Description

This project provides funding for mitigating the potentially adverse effects of the El Nino weather system and the Cotopaxi volcano. It has three components. The second aims for improvement in post-disaster recovery in the above-mentioned areas. The third aims to monitor project implementation through providing funding and assistance to various governmental agencies.
