Project Description

This project finances support the elaboration of Tunisia's foreign investment program (FIP) and Readiness Preparation Plan (RPP). This includes three components: i) hiring a group of experts or consultant firms to bring institutional and legal expertise in the following fields: forestry, rangelands, monitoring and evaluation, environmental and social safeguards, social development, gender, private sector, and climate change; ii) organization of meetings and consultation workshops at local and central levels with all stakeholders; and iii) elaboration of the FIP and RPP investment plans and the proposed projects concept notes.
