### Project Description

The Liaoning Safe and Sustainable Urban Water Supply Project aims to improve water quality and operational efficiency of water supply utilities in the project areas.

There are three components:

- 1) First component: water supply service infrastructure, is to improve water supply services, reduce Non-Revenue-Water(NRW), and increase energy efficiency.
- 2) Second component: water supply service management, is to enhance water supply service management through NRW reduction, water quality monitoring, energy savings, and effective asset management.
- 3) Third component: the project management capacity and institutional strengthening.
