### **Project Description**

The objective of the Emergency National Poverty Targeting Program (NPTP) Project for is to expand the coverage and enhance the social assistance package of the NPTP to Lebanese affected by the Syrian crisis and all Lebanese households under the extreme poverty line. The AF will also be used to enable the Government of Lebanon (GOL) to pilot an innovative graduation program for selected NPTP beneficiaries to 'exit' from poverty, thus contributing to reduced poverty and vulnerability levels and improved program fiscal sustainability in the long run. Hence, a restructuring of the project is being sought to: (i) revise the Project Development Objective (PDO) to reflect changes in the scope of project activities; (ii) revise the Results Framework to be in line with the modified PDO; and (iii) extend the grant closing date by 12 months to accommodate implementation of the pilot.
