This project finances additional funding for the Da Nang Sustainable City Development Project which aims to expand access to improved drainage, wastewater collection and treatment services, the arterial road network, and public transport in selected areas of Da Nang City. This includes infrastructure improvements in drainage and wastewater, bus rapid transit, and urban strategic roads.

The project consists of five main components.

Component 1: Drainage and Wastewater Improvement-Wastewater Collection and Treatment: development of separate sewer/house connection system in the coastal tourism area of My An-My Khe.
