## Project Description

According to bank documents, the proposed World Bank funded project of US\$200 million will be part of Phase I of the US\$510 million government's roads program, and will be likely complemented by a US\$100 million financing requested by the GOL from other donors. This project has three components:

- 1) The first component, Roads Rehabilitation and Maintenance, will primarily finance works for the rehabilitation and maintenance of about 500 kilometers of primary, secondary, and tertiary roads, including road safety and spot improvements as well as supporting consultancy services.
- 2) The second component, Improving Road Emergency Response Capacity, aims at improving the capacity of the Ministry of Public Works and Transport (MPWT) to deal with road emergency works, especially those induced by snow and climate extremes.
- 3) The third component, Capacity Building and Implementation Support, is aimed at building the capacity of the Lebanese agencies in the planning and management of the road sector.
