### **Project Description**

The objectives of the project are to improve the reliability and efficiency of the irrigation and drainage services and strengthen market linkages for irrigated products in selected irrigation schemes. The project comprises four components.

- 1. Institutional modernization. It consists of following sub-components:
  - i. establishment of a new irrigation management entity; and
  - ii. irrigation efficiency improvement.
- 2. Rehabilitation and improvement works. It consists of following sub-components:
  - i. rehabilitation and improvement works; and
  - ii. common services and goods.
- 3. Support to agricultural development and market access. It consists of following sub-components:
  - i. strengthening the capacity of producers (and producer organizations) and linking them to the market; and
  - ii. boosting product marketing and developing competitive value chains.
- 4. Project management, This will cover:
  - i. the equipment cost for the unit;
  - ii. training of project management unit staff;
  - iii. short term expertise;
  - iv. impact assessment studies;
  - v. training, communication, and expertise related to the implementation of the project's environmental and social management framework (ESMF); and
  - vi. the incremental operating costs for the project at both central and regional levels.
