Project Description

The development objective of the Rural Mobility and Connectivity Project for Mali is to improve and sustain road access of farming communities to markets and basic services in the project area, and, in the event of an eligible crisis or emergency, to provide immediate and effective response to it. The project comprises of four components. The first component, rural roads improvement consists of following sub-components: (i) rural roads improvement works; (ii) small common facilities; and (iii) preparatory and other studies. The second component, routine maintenance and road safety focuses on the routine maintenance of rural roads in good condition improved by the project or by other development partners. It consists of following sub-components: (i) routine maintenance works; and (iii) road safety. The third component, operational support consists of following sub-components: (i) project management; (ii) social safeguards; and (iii) citizen engagement. The fourth component, contingent emergency response will be available should the need arise to redirect some of the project resources to contribute with other projects in the Mali portfolio to responding to an emergency.
