Project Description

According to bank documents, the stated aim of this project is to improve the efficiency and accessibility of targeted justice institutions.

The Project will have several components:

Component 1: Improving Operations of Courts and Institutions under MOJ Authority. This component will include: investments in ICT across the judiciary to maintain and enhance core functions of the courts; courthouse rehabilitation and construction to improve the system's ability to deliver services, especially in poor and underserved regions of Romania; and community awareness activities to increase responsiveness of the courts to the needs of local communities, especially for vulnerable groups.

Component 2: Enhancing National Trade Registry Office Performance. This component supports the NTRO at the central level and throughout its 42 locations across Romania to improve the 28 services offered to users including businesses, financial institutions, insolvency practitioners, attorneys, bailiffs, notaries, courts, prosecutors and citizens, in line with EU standards. They include, among other things, the provision of certificates, information about companies, entries into the trade registry and steps related to processing of bankruptcy proceedings.

Component 1: Improving Operations of Courts and Institutions under MOJ Authority. The ICT investments at the Public Ministry will improve the core functions of the prosecution service in a manner similar to the courts. The WAN and LAN rollout in prosecution offices as well as cabling and reconfiguration of the LAN of the Bucharest Tribunal's Prosecutor Office will enable prosecutors to share information quickly and securely with each other.
