Project Description

The development objective of Additional Financing of Sustainable Natural Resources Management Project for Sudan is to increase the adoption of sustainable land and water management practices in targeted landscapes. This project has three components. 1) The first component, Institutional and Policy Framework, finances technical assistance, workshops, goods, services and operational costs to build or strengthen national, state and local level capacities to strengthen policy and regulatory frameworks, remove critical knowledge barriers, and develop an enabling environment for the on-the ground activities. 2) The second component, Community based sustainable management of rangelands, forests and biodiversity, finances technical assistance, training, investments, goods, works, services and operational costs related to the promotion of wider adoption of community-based Sustainable Land and Water Management (SLWM) practices in forests and rangelands in the targeted communities. 3) The third component, Project Management, Monitoring and Evaluation, consists of technical assistance, operational costs, goods, services for the monitoring and evaluation.
