According to WB website, the development objective of the Aviation Investment Project for Vanuatu is to improve operational safety and oversight of international air transport and associated infrastructure in Vanuatu. The additional financing will be used for additional activities in two components:

Component 1. International airport infrastructure investments to invest in international aviation infrastructure to meet and maintain minimum International Civil Aviation Organization (ICAO) safety and security standards at Vanuatu's three international airports: Bauerfield, Whitegrass, and Pekoa airports.

Component 2. Project implementation support finance to the complexity and intensified urgency of the project resulting from recent delays.
