## Project Description

Components include direct lending to eligible small and medium-sized enterprises (SMEs), and channeling funds through other participating financial institutions for further on-lending to eligible SMEs.

Financial Intermediary: A commercial bank or financial institution that receives funds from a development bank. A financial intermediary then lends these funds to their clients (private actors) in the form of loans, bonds, guarantees and equity shares. Financial intermediaries include insurance, pension and equity funds. The direct financial relationship is between the development bank and the financial intermediary.
