Project Description

The development objective of the project is to improve access to electricity in rural and peri-urban areas within the Republic of Yemen. The project has three components.

- 1. Financing for off-grid solar. This component has two sub-component;
 - i. Providing basic electricity supply to households.
 - ii. Restoring electricity supply to critical services facilities.
- 2. Implementation support and market strengthening. UNOPS will contract technical service providers and NGOs to provide market strengthening activities, including inter alia
 - i. an awareness campaign and consultations
 - ii. technical training and capacity building to firms along the solar supply chain to increase their reach and strengthen the job-creation aspect of the program;
 - iii. technical assistance to the financial sector to develop derisking mechanisms for commercial lending for solar;
 - iv. technical standard definition and dissemination, and establishment of testing centers in cooperation with local universities to enhance the technical standards in the industry; and
 - v. support for recycling of batteries from the project as well as the market more generally to minimize the environmental risks from disposing hazardous materials.
