## Project Description

The development objective of Second Energy Efficiency Project for Montenegro aims to improve energy efficiency in health sector buildings, and to develop and demonstrate a sustainable financing model. There are 3 components in this project:

1/ Energy Efficiency (EE) investments in health sector buildings in:

- the state-owned public health sector facilities for energy cost savings and using an energy savings capture model;
- related technical services as energy audits, designs, technical revisions, works supervision, technical and social monitoring before and after the EE building renovations with energy performance certificates for all retrofitted facilities; and
- installation of energy consumption monitoring equipment in health sector buildings.

2/ Technical assistance aims to enhance local EE capacity related to:

- A long-term sustainable EE investment framework
- The preparation, implementation, and maintenance of EE investment; and
- Gender-informed communication and awareness raising campaigns.

3/ Project implementation supports by payments for PIU staff and a technical EE expert, the government Technical Service Unit (TSU), the project-related operating, costs, and financial audits.
