The objective of the project is to strengthen the institutional capacity of selected water sector agencies and increase water service coverage in target cities. The additional financing (AF) will:

- i. Fill a financing gap by replacing existing counterpart co-financing to ensure timely implementation, which has been threatened by an unanticipated change in Government of Angola (GoA's) financial situation, linked to the downturn in global oil prices; and
- ii. Scale up support to sector institutions to undertake their mandates for sanitation management and to address the challenges of urban sanitation through a pilot project in sanitation.

The AF will finance the following components:

- 1. Water supply institutional strengthening and capacity development;
- 2. Water resources management;
- 3. Rehabilitation and expansion of water supply production and distribution;
- 4. Management and engineering support; and
- 5. Piloting small-scale sanitation service delivery in peri-urban areas.
