## **Project Description**

The additional financing for Health Sector Support Project in Bangladesh will enhance the capacity of the Ministry of Health and Family Welfare to respond to the Rohingya crisis in Cox's Bazar district, Bangladesh by extending Health, Nutrition, and Population sector's services to the displaced population.

Overall, the proposed additional financing will support development of capacities for coordination, management and delivery of the essential health services to the displaced Rohingya population in two contexts:

- a) New and temporary Health, Nutrition, and Population services in the displaced camps
- b) Existing ministry's facilities that provide services to the displaced population, primarily the Sadar District Hospital
