This will be done by through the Catalytic subprogram of the Cooperation in International Waters in Africa (CIWA) MDTF. The Catalytic subprogram will generate, share, and manage knowledge that can facilitate cooperative development and management of international waters; explore potential high impact collaborative investment opportunities in defined basins and regions; and create shared understanding of the opportunities, risks, costs, and benefits of cooperative development and management of international waters among stakeholders.

The specific objectives of this sub activity are to undertake a comprehensive assessment of the ground and surface water potential in the IGAD member countries, strengthen the regional ground water information data availability and support IGAD member countries to Strengthen and manage the sustainable development of their groundwater potential.
