### Project Description

The proposed Project plays a significant role in improving Nepal's transport and trade connectivity with its neighbors India and China and also Bangladesh and Bhutan (via India). The project will support "(a) Improvement of the existing Nagdhunga-Naubise-Mugling (NNM) Road (96 km on the pivotal north-south trade corridor connecting Kathmandu and Birgunj, plus construction of a new 2-lane bypass from Sisne Khola to Dharke (~12 km); and (b) Upgrading of the Kamala-Dhalkebar-Pathlaiya Road (KDP) Road of the East-West Highway from 2-lane to 4-lane."
