## Project Description

According to bank documents, the Project Objective is to increase the coverage of Egypt's Universal Health Insurance System (UHS) in Phase 1 Governorates and to strengthen UHS-related governance and institutions. The project has three components:

1. Enrollment and empanelment of the population into UHS (US\$300 million). This component will support the enrollment of the population in UHS as well as the empanelment of enrollees with General Practitioners (GPs). This will be achieved by supporting, inter alia (i) the enrollment and empanelment for the entire population in Phase I governorates, (ii) IEC campaigns to raise awareness about UHS among the population, (iii) identification of the vulnerable who are eligible for premium subsidies, (iv) premium subsidies for the vulnerable, and (v) government contribution to UHS for civil servants.
2. Strengthening capacity of UHS-related agencies, UHS governance and creating an enabling environment (US\$200 million). This component will support:
  - Capacity building for UHS-related agencies, with a focus on the UHIA and GAHAR to better help them carry out their mandates.
  - Institutional arrangements and governance for UHS: this includes support for UHS oversight and coordination platform.
  - Creating an enabling environment for UHS, including the policy environment for private sector participation, citizen engagement mechanisms at both the central and Governorate level such as 24X7 Call Center, and Local and National Health Assemblies/Forums.
3. Technical assistance, project management and monitoring and evaluation (US\$10 million). This component will support TA including capacity building and analytical activities for the establishment of the new UHS. It will include support for UHIA, GAHAR, and the Social Justice Unit of the MOF. In addition, TA will be provided to EASPMTM including on the development of procurement guidelines. Project management and project monitoring and evaluation (M&E) will also be supported through this component.
