 - Support a surveillance system to facilitate recording and on-time virtual sharing of information
- 2) Supporting preparedness through laboratory system strengthening
- 3) Case management and clinical care
 - Strengthening of health facilities and service delivery
 - Strengthening of human resource surge
 - Logistics and ambulance services
- 4) Community Engagement, Risk Communication and Advocacy
