### **Project Description**

According to the bank's documents, "The proposed project would include five components: (i) Institutional Strengthening, aiming to modernize and strengthen the capacity of WRD and ASDMA, in addition to other related agencies such as the Assam Water Research and Management Institute (AWRMI); (ii) Integrated River Basin Planning and Management, aiming to develop an integrated planning framework for multi-sectoral investment planning and effective management of the Brahmaputra and Barak Basins that involves all relevant stakeholders; (iii) Flood and Erosion Risk Management, aiming to strengthen disaster risk management in Assam, particularly for the two major water-related risks of floods and riverbank erosion, that are already serious and could be exacerbated under a changing climate; (iv) Project Management, aiming to ensure effective implementation of project activities and monitoring and evaluation (M&E) of project implementation progress, outputs and outcomes; and (v) Contingent Emergency Response Component (CERC), which will allow for rapid reallocation of loan uncommitted funds in the event of an eligible emergency as defined in OP 8.00."
