#### **Project Description**

According to the bank's documents, the proposed project's objective is "to improve the delivery, reliability and efficiency of electricity supply in selected areas in Bangladesh and strengthen institutional and regulatory capacity."

The proposed project will "support a part of the overall government programand contribute to three results areas (i) increased distribution network capacity, climate resilience and digitalization; (ii) increased integration of distributed energy resources and (iii) strengthened sector institutional and regulatory capacity. Results Area 1will focus on network strengthening, expansion and rehabilitation to ease existing constraints and meet the rapidly growing demand in the country. These network investments will be paired with new and transformative network elements such as System Control and Data Acquisition (SCADA), Advanced Distribution Management System (ADMS) and Advanced Metering Infrastructure (AMI). Results area 2 will focus onincreasing integration of distributed energy resources such as rooftop solar, BESS and EV infrastructure in selected PBS's. Results Area 3 will focus on technical assistance and capacity buildingforelectricity sector institutions –BREB, Power Cell and BERC-to effectively respond to emerging challenges and opportunities in the sector."
