## **Project Description**

According to bank documents, the project objective is to improve financial sustainability of the electricity sector, enhance access to reliable electricity services, and facilitate clean energy transition in Sudan.

The project is designed to include four components:

1. Component 1 will support short-terms measures to mitigate the ongoing power shortage through the use of decentralized solar PV generation and energy efficiency appliances.
2. Component 2 will address electricity access deficits for households and public facilities through the use of solar PV systems.
3. Component 3 will support the development of grid-scale solar and wind projects, including a transaction support. It will contribute to reduce the sector dependency on costly thermal generation and address supply deficit.
4. Component 4 will support overall project management as well as the sector's reforms and capacity building.
