### Project Description

According to the World Bank project page, the objective of the proposed project is to promote economic inclusion and resilience of the youths who are not in employment, education, or training (NEET) in Bangladesh.

The proposed project will help Bangladesh to achieve SDG 8.6 - reducing the share of NEET population and help the country to establish a system of converting its NEET youth to a productive workforce in various economic sectors with special emphasis on rural women and disadvantaged groups through (i) introducing a holistic approach to youth development, with interventions targeting acquisition of in-demand skills, improvement of psychosocial well-being and resilience, and creating an enabling environment for participation and inclusion; (ii) continuous support at every step, including information and outreach, skills training, and transition to the labor market for wage employment or self-employment / entrepreneurship; (iii) multimodal engagement with the local private sector as potential employers, as providers of work-based learning, and as providers of information on skills demands and skills gaps; (iv) a selection model with eligibility criteria to ensure strong focus on inclusion of underserved NEET youth, particularly of young women and disadvantaged; (v) strengthening the capacity of state and non-state actors, including private sector and CSOs, to support youth development, better coordination, research and tracking of youths and monitoring and evaluation.

The project will be implemented by an integrated Project Management Unit, under the leadership of the MoYS, and partner agencies from the Ministry of Education, and other relevant Ministries, supported by implementing partners such as NGOs and community-based organizations.
