## **Project Description**

According to World Bank documents, the objective of the proposed project is to support the development of an inclusive and competitive milk value chain, focusing on smallholder livestock rearers and producer-owned institutions in the project area.

The proposed project will address key well known gaps and deficiencies in the dairy sector in selected states in India and support the sector's transformation towards increased productivity, resilience, and profitability. By doing so it will contribute to key aspects of the GoI and the Bank's CPF strategic objectives related to faster and broader agriculture sector growth and inclusive development. The project will also work closely with the pipeline project under development – Animal Health System Support for Improved One Health (AHSSOH) – to enhance animal health management. In line with the PDO, the project will have four interlinked intervention areas to support the development of inclusive and competitive milk value chain viz., (i) Enhancing institutional capacity and sustainability; (ii) Strengthening dairy market development; (iii) Enhancing food safety and quality; and (iv) GHG mitigation and climate resilience.
