### Project Description

According to the World Bank, this Development Policy Operation aims to help the authorities to: (i) increase support to refugees and households, and (ii) build resilience and enhance competitiveness to reduce vulnerabilities to future shocks. This operation is part of a package of coordinated financial assistance to Moldova from international partners prepared in response to the ongoing socio-economic emergency. The proposed operation is expected to benefit from US\$25 million dollars in concessional financing from the Global Concessional Financing Facility to support the authorities' efforts to deal with the refugee crisis.
