## **Early Warning System Project Analysis**

Environmental and Social Risk Classification (ESRC): High

The AF activities have similar risks and impacts to the Project since they are related to the support of the expansion and access to GBV services under Component 2, and there is no change in terms of geographical project areas. The AF activities are not anticipated to cause conversion of natural habitats or generate large-scale pollutants given the small-scale nature of the activities. However, there are potential small scale environmental, health, and safety risks that may result from the construction of the small-scale infrastructure for women and child-friendly safe spaces.
